Regulations for substances in contact with food

EU (European Union) Framework Regulation for Food Contact Substances EC/1935/2004

The above mentioned products are suitable for the production of food contact materials provided that the standards of a quality management system are met.

With regard to silicones, there is currently no "individual measure" of the EU, so that reference is made to Art. 6 of EC/1935/2004, which declares "National specific measures" to be valid.

Regulation on Good Manufacturing Practice of Food Contact Materials EC/2023/2006

The framework conditions for quality assurance in the individual stages of the production chain of food contact materials are fulfilled. Apart from these general requirements, there are so far only special requirements for printing inks, which are not applicable to the above-mentioned products.

Germany (National specific measures) LFGB Lebensmittel-, Bedarfsgegenstände- und Futtermittelgesetzbuch (Food, Commodities and Feed Code)

The LFGB is the German framework law regulating the conditions and quality management systems under which food, food contact materials, consumer goods, animal feed, etc. may be produced and processed. It regulates, among other things, the areas that are not yet regulated by EU law. Specific conditions such as positive lists, maximum values, etc. are laid down in individual measures such as the Consumer Goods Ordinance or the BFR Plastics Recommendations, as set out in LFGB §§ 30, 31.

The above-mentioned products are suitable for the production of food contact materials, as they do not contain any substances on the banned lists and the standards for quality assurance are met.

Consumer Goods Ordinance

The Consumer Goods Ordinance is the implementation of EC/72/2002 with amendments and contains positive and prohibited lists as well as limit values for the use of substances in food contact materials. The above-mentioned products are suitable for the production of food contact materials because they do not contain any substances on the banned lists.
